Update on Analyst / Investor Conference Call – Post listing of our subsidiary 'Ujjivan Small Finance Bank Limited' (hereinafter referred to as 'USFB')

We wish to inform you that a meeting of the Board of Directors of our Company is scheduled to be held on **Monday, February 03, 2020** to discuss and approve, inter alia, the unaudited financial results (standalone and consolidated) of the Company for the quarter ended December 31, 2019.

Pursuant to the above and in accordance with the "Ujjivan Code of Conduct for Prevention of Insider Trading", the trading window for dealing in the shares of the Company and its subsidiary 'Ujjivan Small Finance Bank Limited' by its designated persons has already been closed from January 01, 2020 and will open 48 hours after the announcement / declaration of the aforesaid financial results on February 03, 2020.

Please take this intimation in compliance with the requirement of Regulation 29 and other applicable requirements of SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015.

Further, we would like to inform that USFB has got listed on NSE and BSE on December 12, 2019 and will be announcing to stock exchanges all its material events and developments including but not limited to declaring its financial results and scheduling its analysts / investor conference calls for discussing its results.

USFB is a material listed subsidiary of our Company 'Ujjivan Financial Services Limited' (UFSL / Company) and is the only operating company within the group. Accordingly, the conference calls with Analysts and Investors will henceforth be handled by USFB following the announcement of its standalone results. Therefore as a general practice, UFSL will not be holding a separate conference call with analysts and investors unless there is any material event attributable to its own standalone operations as a holding company in any quarter, when a separate disclosure will be made by the Company.

In this connection, please note that USFB in its intimation letter dated January 13, 2020 submitted to the exchanges has intimated stock exchanges about scheduling of its analyst / investor conference call on <u>January</u> 22, 2020 at 5;30 PM IST for discussing its business and financial performances for the quarter ended December 31, 2019 and the same is being annexed hereto.

We request our investors and analysts to take note of the details relating to the aforesaid conference call of USFB and may feel free to join the same.



Please note however, that the analyst/ investor conference call proposed to be held by UFSB will be based on USFB's standalone financial statements prepared in accordance with the Companies Act, 2013 and Indian GAAP, whereas our Company will be preparing its financial statements in accordance with the Companies Act, 2013 and Ind AS. Ind AS differs in many respects from Indian GAAP, and our financial statements prepared under Ind AS may not be comparable to the financial statements prepared by USFB under Indian GAAP. While investors are free to join the analyst/ investor conference call hosted by USFB, our investors should rely solely on the financial statements prepared and disclosed by UFSL, for an assessment of UFSL's financial position.

We will arrange to resolve any specific queries related to the consolidated financials if they are received from any of our investors.
